1. **Date:** Friday Dec 4th Time: 4pm-8pm | Saturday Dec 5th Time: 2pm-7pm
2. **Registration Deadline:** November 4th, 2026 to be able to assign spaces
3. **Booth size:** 10 by 14' – If more space is required, please specify on previous page. No vehicles will be permitted at your booth. Vehicles must be moved after set-up and parked in the designated area during the event.
4. **Price per Booth:** \$125 – One day (non-refundable). Payment via cash, check, or card must be provided with application to confirm booth space. Booth will be so general public can shop, eat, and enjoy.
5. **Electricity:** Absolutely NO electricity in any form will be provided at this event due to additional festivities. Generators are permitted (if needed) by vendor. No water access will be provided.
6. **Location:** 400 Block of Front Street in Railroad Park | Yoakum, Texas 77995
7. **Set-up:** 2pm-4pm day of. | Tear down: After 7pm Saturday. Please do not depart sooner than 7pm. We would like windows/selling area to open into Park. This event is five hours in length and vendors are expected to stay for duration. We will advertise that you are in town for dinner so locals can come out and enjoy your selection of favorites!
8. **Uncovered Outdoor Area:** Exhibitors must provide their own materials, tents, fans, etc. Booth spaces will be marked upon your arrival and a representative will be present to assist. Call (361) 293-2309 or text (361) 293-1506 to coordinate.
9. **Sales Tax:** Exhibitors are responsible for collecting and reporting as is legally necessary.
